Multi Generational Housing & Community Centre is currently looking for a dedicated, motivated, and passionate individual to join our team as a Registered Nurse in our Long Term Care unit, evening shift.

**Duties and Responsibilities Include:**

- Promoting quality resident centered care through ongoing detailed assessment and implementing prescribed interventions (medications, medical treatments and procedures) and performing independent nursing interventions
- Ensuring the implementation and ongoing administration of the Resident Care Plans. This includes leadership, support and direction to LPNs and HCAs on an ongoing basis
- Coordinating and participating in MDS data entry by communicating and observing the resident, communicating with direct care staff, interdisciplinary health professionals, and family
- Developing and maintaining a good rapport and therapeutic relationships with Residents, families, management, nursing staff, other departments, and the general public
- Participating in accreditation, accommodation, and other quality improvement activities and projects as required

**Essential Skills and Qualifications Include:**

- Baccalaureate of Nursing is required
- Registration in good standing with College of Registered Nurses of Alberta (CARNA)
- Minimum of 1 year work experience as an RN
